A. How does our faith speak to eviction and its solution?

Jesus died for our shame and identified with those who are shamed: Jesus was betrayed; abandoned; arrested and bound, denied; falsely accused; falsely tried and falsely convicted, beaten, spat upon and ridiculed. IV. The Fierce Urgency of Now: State of the Union of housing for non-property owners

- √ % of renters nationally:35% Census data
- ✓ Median rent \$1,226 and double digit increases; Census data
- ✓ Changes in business practices have allowed the vultures in!
- √ The Eviction Moratorium is especially disastrous for mothers with children

...eviction is something like the feminine equivalent of incarceration. We have a lot of poor black men being.... locked up, and then we have a lot of poor African-American women being locked out. Especially mothers. ~ Matthew Desmond



National Eviction Moratorium expires July 31

- ► When expanded unemployment benefits and eviction protections in the Coronavirus Aid, Relief, and Economic Security, or CARES, Act ended July 31, 2020, millions faced eviction. On September 4, the CDC announced a federal moratorium on evictions.
- ► Beginning Monday, August 2 if your state/city/county DOES NOT have its own protections, landlords can begin the process of eviction

National Eviction Moratorium expires July 31

- ► Important to know this in order to:
 - 1) recognize the timeline and that this is a process
 - 2) to prevent extra-judicial evictions for tenants, also called "self-eviction"— people think the sheriff will come kicking the door down almost immediately upon non-payment of rent. Not so.

A. What is Eviction?

Time difference: some states (TX) 7-10 days; (IL) 5-90 days from filing until tenant is out



B. What is Eviction?

► Eviction is a process that ultimately ends with the tenant being removed by the sheriff, but after a process.

► Tenants with counsel always fare better than those without.

Eviction is violence.

C. What is Eviction?It is a process Where can you assist in the Eviction Process?

- 1. A legal notice to cure/fix problem pay rent is posted on tenants' doors
- 2. If issue not corrected/rent not paid, landlord files eviction lawsuit/unlawful detainer with court and notice of this lawsuit
 - 3. Court Date/Hearing
 - 4. Judgement/Writ of Restitution/Eviction

2. If issue not corrected/rent not paid, landlord files eviction lawsuit/unlawful detainer with court and notice of this lawsuit

- ► Provide support: with filling out documents, summons, notices, requests for tenants.
- ▶ Provide Education: Host Know Your Rights workshops; workshops on how to organize with your neighbors if there are issues or common ground;
- ► Provide Legal support: Lawyer or other professional volunteer in your parish or org to assist tenants with documents they receive; language support.
- ► Support Tenant Right to Counsel—the Gideon Rule Legal Push for tenants

3. Court Date/Hearing

➤ Support with documents, summons, notices, requests for tenants. Is there a lawyer or other professional volunteer in your parish or org to assist tenants with documents they receive?

- ► Court support: most tenants show up to court without counsel and lose. The way most states' eviction laws work, a landlord CAN go into an eviction filing in bad faith: filing DESPITE local protections or obvious bad faith or harassment.
- Support Tenant Right to Counsel—the Gideon Rule Legal Push for tenants

4. Judgement/Writ of Restitution/Eviction

- ► Standing with a tenant to occupy the house in the face of eviction mass action/occupy help for homes of tenants literally facing the sheriffs' eviction boot and rifle
- ▶ Negotiating with the landlord or bank to remain
- ► Housing supports
 - Identify those with spare rooms in your community; could a church encourage members to open their homes and churches, Jill shares two models of this
 - Start a shared housing program
- ▶ New apartment rental assistance; Lake Ave Church example, \$90,000
- How to encourage a city to have a rental assistance program, Advocacy, I' the prophets of old

VIII. What are some other ways to support those facing evictions?

A. Find a local tenant union and invite them to your church for outreach. Host a local tenant union meeting at your church. Many new groups need support like location (when COVID safe), Zoom support, and recognition of the struggle by your parish or org to give legitimacy.

What are some other ways to support those facing evictions?

B. Host events/programs on key topics: Tenants know your rights workshops; getting docs together to apply for assistance programs; how to negotiate with your landlord; how to talk to neighbors and community members about housing; direct advocacy to city council, state, etc.
